*The Violence Against Women Reauthorization Act of 2013 (VAWA) amended the Clery Act to require institutions to compile statistics for incidents of domestic violence, dating violence, sexual assault, and stalking. In 2013, Rape/Sex Offense (Forcible) and Rape/Sex Offense (Non-Forcible) is captured under Sexual Assault. Sexual Assault is an offense that meets the definition of rape, fondling, incest, or statutory rape as used in the FBI's UCR.*
